- 1. Stuart welcomed all to the meeting and introduced Wendi Lees, Practice Manager CMG
- 2. The Minute of the last meeting on 26th January 2022 was taken as read and approved by Ken Drysdale and seconded by Jim Ray
- **3. Matters arising** There were no Matters arising from the Minute which are not included in the agenda below.

4. Housing v Health Care project –

Ethel reported she has been in contact with Chairpersons from Montrose PPG and Academy Medical Group, Forfar. Housing and Health & Social care are not a high priority on their agenda at this time. But both practices are aware that this potentially is something that may affect them in the future. They both support us in raising the issue at a higher level. Raveswood Medical Practice PPG in Forfar have referred the communication to the Practice Manager. The Chairperson of Academy Medical Practice will speak to Lour Road Practice, Forfar and Kirriemuir Practice regarding this issue and report back accordingly. Monifieth PAG have concerns regarding housing developments and they do support us at this time. The group agreed to proceed with expressing our concerns to the Scottish Government with the First Minister being the favoured point of contact and to include the Health Secretary in communications. Wendi Lees said we have her support and that of the GP's. A sub group will meet to prepare a draft letter for approval of group members.

5. Newsletter/Information sharing

The summary of comments given by group members relating to finding a way to communicate a positive information sharing format was discussed. It is recognised this is more complex than first thought. However, the varied areas of concern are recognised as valuable points to address, namely – repeat prescriptions, the role of the Practice Pharmacist, services available from PPCC, publicity and information boards, telephone system and health practitioner services. It was agreed this will require input from practice management to take it forward.

The current restrictions still in place regarding Covid recovery does hinder effective ways to address the issues at this time but we can begin to put a plan of action in place. The Practice Pharmacist will be invited to speak to the group to address issues relating to her role. Points raised with Wendi related to conflicting advice being given to patient's regarding making appointments and a request for patients waiting for an appointment to be advised if the doctor is called away and given the opportunity to wait or make another appointment. Other points raised were relating to concerns of treatments and medication. Issues cannot
